The Ad Hoc Structure Review Task Force, since its establishment in March, has endeavored to do the research and input necessary to propose a right-sized suite of solutions for structure of the Winnebago County Board. We spoke with other counties, asked for feedback from supervisors and departmental stakeholders in the form of questionnaires, and digested this information thoughtfully. As per our charter, we are recommending to you, the Judiciary and Public Safety Committee, a set of three solutions to choose from. They are laid out below. As of now, we have twelve standing committees and three commissions and boards of major departments.

Option 1 - Nine Standing Committees

This option is a tempered solution that is unique for Winnebago County. The new standing committees are laid out with what will be absorbed into them underneath.
