3 **ORDINANCE: Amend Section 5.01(2) and 5.07(5) of the**
4 **General Code of Winnebago County**
5 **(Increase Per Capita Daily Cost Fee and**
6 **Daily Jail Fee)**

8 **TO THE WINNEBAGO COUNTY BOARD OF SUPERVISORS:**

10 **WHEREAS**, in October 2008, the Winnebago County Board established a per capita
11 daily cost charge as well as a jail inmate fee to be effective through July 1, 2010; and

13 **WHEREAS**, your undersigned committee believes that said charges and fees should be
14 amended to reflect increases in the cost of living as well as increases related to the costs of
15 incarcerating individuals in the Winnebago County Jail.

18 **NOW, THEREFORE, BE IT ORDAINED** by the Winnebago County Board of
19 Supervisors that Section 5.01(2) of the General Code of Winnebago County be amended to
20 read as follows:

22 **5.01(2) Per Capita Daily Costs**

23 (a) The per capita daily charge for maintenance and costs of the prisoners boarded in the
24 Winnebago County Jail is hereby established. Each prisoner shall be charged for all meals
25 served and for each day incarcerated, regardless if the prisoner actually consumes each meal.
26 The per day charge for all Huber Law prisoners shall be established in the following amounts
27 commencing on the following dates:

34 **BE IT FURTHER ORDAINED** by the Winnebago County Board of Supervisors that
35 Section 5.07(5) of the General Code of Winnebago County be amended to read as follows:

37 **5.07 Jail Inmate Fees. . .**
38 **(5) Daily Jail Fee**

39 (a) For expenses incurred by Winnebago County for crimes for which an individual is sentenced
40 to the Winnebago County Jail or for which the individual was placed on probation and confined
41 in Jail, the Winnebago County Board hereby establishes a daily per person Jail Fee. The rate of
42 the daily jail fee shall be established in the following amounts commencing on the following
43 dates:
