ARRIVAL:

We have planned for arrival to be at the Winnebago County Courthouse, located at 415 Jackson Street in Oshkosh, to be between 8:15 and 8:30. Busses planning to arrive late should let us know.

ELECTED OFFICIAL BREAKOUTS:

Based on the elected official titles chosen by the students, students will be separated into breakout sessions as listed below. School officials may pick whichever breakout they would like to attend. MOCK TRIAL:

At the conclusion of the breakouts, all the students will assemble for the mock trial in the County Board Room/ Branch 1. Circuit Court Judges will assemble in the jury box and participate as the jury. District Attorneys, Clerk of Courts, and Sheriffs will be chosen to be other participants in the mock trial.

A pizza lunch will be provided by the American Legion. Lunch will occur in Room 500 and Room 60. A division of students will be announced prior to lunch. The county has refrigerator space for students who are bringing their own lunch. Elected officials and department leaders have been invited to eat with the students.

At 12:45, students will break into their elected official groups and take a picture on the steps. Elected officials have been invited to be in the picture with their respective group.

County board members will participate in a mock county board session. Students who are county board members may submit ideas for resolutions prior to Youth Government Day. A sample resolution is included in this packet. Following the passage of a resolution, the county executives will decide whether to veto or pass a resolution.
