3 **RESOLUTION: Authorize \$300,000 of Funding Needed**  
4 **to Begin Acquisition of Right of Way for**

9 **TO THE WINNEBAGO COUNTY BOARD OF SUPERVISORS:**

10  
11 **WHEREAS**, the Winnebago County Board of Supervisors supports the design and  
12 reconstruction of CTH T from CTH Y to CTH G; and  
13

14 **WHEREAS**, the project will begin approximately .25 miles south of CTH Y and continue  
15 north to the intersection of CTH G, a distance of approximately 4 miles; and  
16

17 **WHEREAS**, the project is in the Winnebago County Five-Year Capital Improvement Plan;  
18 and  
19

20 **WHEREAS**, the project will include construction of one roundabout which will be located  
21 at the intersection of CTH Y and CTH T; and  
22

23 **WHEREAS**, the adjacent area near the CTH T corridor is expected to continue to  
24 develop rapidly in the near future as other local and state highway projects are completed; and  
25

26 **WHEREAS**, the roadway surface on CTH T is continuing to deteriorate due to the age  
27 and condition of the original concrete road bed and inadequate subgrade materials beneath it;  
28 and  
29

30 **WHEREAS**, the estimated cost to acquire the right of way needed to construct the  
31 project is \$300,000.  
32

33 **NOW, THEREFORE, BE IT RESOLVED** by the Winnebago County Board of  
34 Supervisors that it hereby appropriates the sum of \$300,000 from the General Fund of  
35 Winnebago County for the right of way costs related to the reconstruction of County Trunk  
36 Highway T.  
37

38 **BE IT FURTHER RESOLVED**, by the Winnebago County Board of Supervisors that  
39 funds to pay for said deficit are hereby appropriated from the General Fund of Winnebago  
40 County with the General Fund to be reimbursed from a subsequent bond issue.
