9 **TO THE WINNEBAGO COUNTY BOARD OF SUPERVISORS:**

10 **WHEREAS**, the current runway broom has aged beyond its economic useful life; and

11 **WHEREAS**, the current equipment does not work properly due to a balancing problem  
12 with the broom; and

13 **WHEREAS**, this problem is such that the broom can only be used in one direction; and

14 **WHEREAS**, there are additional mechanical problems with the equipment making it  
15 difficult to keep it in an operational state due, partially, to its age; and

16 **WHEREAS**, the new broom can be used year round to keep the runways clear of debris  
17 and is especially useful in winter in being able to clear snow right down to the runway surface,  
18 thus reducing the need to use sand and other materials to make the runways safe for use.  
19

20 **NOW, THEREFORE, BE IT RESOLVED** by the Winnebago County Board of  
21 Supervisors that it hereby appropriates \$650,000 for the purchase of a new runway broom for  
22 Wittman Regional Airport.  
23

24 **BE IT FURTHER RESOLVED** that funds to pay for said equipment be transferred from  
25 the General Fund of Winnebago County with the General Fund being reimbursed from grant  
26 funds of \$520,000 and a subsequent bond issue of \$130,000.  
27

28 **Fiscal note:** Approximate principal and interest on the debt would be \$16,000 per year for the  
29 10-year payback period.
