## **Department reports**

Circulation Services Report, Nancy Baird

Hong Zhang, currently a library assistant casual employee, has accepted the permanent library assistant position. Thirty-three new volunteers started in 2022.

Youth Services Report, Katrina Wulff

The drop-in Stuffed Animal Clinic will be held January 21 between 10:30-11:30 a.m. Youth staff regularly visit every NJSD elementary school. In the month of December, 567 students were read to, and most did an extension activity as well.

Technical and Adult Services Report, Nicole Hardina-Wilhelm

46 individuals participated in the Fall into Reading Challenge between November 1 and December 31, with 317 reading prompts and activities completed. Tech services staff visited the Menasha Public Library to learn more about 9xx, an acquisitions software (add-on) to simplify and streamline the ordering process.
