5. Grundy Quarry – Conditional Use Permit Renewal

Zoning Administrator updated the committee regarding complaints filed against Michel's Materials and Michel's Materials response to alleged complaints. Michel's Materials hired and independent consultant (Vibra Tech) to investigate the complaints. In summary, there was no definitive evidence that past blasting practices caused alleged property damages according to a report provided by Vibra Tech. Zoning Administrator recommended that the committee renew the conditional use permit in accordance with the term and general conditions of the conditional use permit as previously established by the town. Blasting is not included during the renewal period.
