Overdose Fatality Review (Health Dept)	 Jennifer Skolaski, Sandy Shaffer, and Alex Belville are presenting at the National OFR Conference on the Winnebago County We Heart You work from the We Heart You event to the new PSA. The "Thriving in Recovery" PSA will be launched in Winnebago County February/March, and is being shared statewide and nationally as a resource that humanizes substance use. We are working with DOJ to put together a media plan on how to release the PSA. The We Heart You App which is a mobile app that connects people to substance use resources, whether they're struggling, looking to help loved ones, or are a professional wanting to share resources, will be available for our community in February. We hope to share the app with the Safe Streets Committee and make this free app available to anyone that is seeking help. The Solutions Peer Response Team has been working with the jail since September 6. Since that time the program has exhibited promising preliminary successes. In the first three months of the program, 95 incarcerated individuals have received peer support services resulting in 596 contacts (488 in-person visits and 108 phone calls). They have successfully helped 14 people get to treatment and sober living, and 12/14 are still sober. We are strengthening relationships with Oshkosh Fire

	Department, County Crisis Center, and Human Services, as well as looking to expand to UW-Oshkosh Police Department and Probation and Parole.
