- Overdose Spike Alerts PH is working to coordinate a team of four people to Beta DHS's new spike alert system. We are working to implement a standard overdose spike alert system within PH.
- Amanda Tennyson, Harm Reduction Program Coordinator and Sarahjean Schleuchtermann, Epidemiologist both awarded full scholarships to Attend a training on qualitative and quantitative data NACCHO to further improve the Harm Reduction Program.
- Continuing to provide Narcan training to school district staff throughout the county.

- The second We Heart You: Recovery in Our Community was held on March 13, 2024. Over 370 people were in attendance at this event
- ➤ The Handle with Care program expanded to Omro, Menasha, Neenah, Fox Crossing, Winneconne, and Winnebago County. Law enforcement partners meet on a quarterly basis to discuss improvement of the program.
