WINNEBAGO COUNTY PUBLIC HEALTH'S ROLE IN SUBSTANCE USE AND OVERDOSE PREVENTION

WCPH utilizes evidenced-based prevention, systems change, and harm reduction efforts to engage people, reduce stigma, prevent early-onset substance use and deaths by overdose, and reduce the spread of HIV, Hep-C and other STIs.

Functions of Public Health

Provide administrative support and oversight of OFR

Partner with community to pursue grant funding and serve as fiscal agent, when needed

Identify opportunities for policy and systems changes

Collect, analyze, and report data to the community

Partner with those most impacted to better understand community needs and solutions

Engage in community-led initiatives that support recovery

Lead harm reduction and overdose spike alert efforts

National Overdose Prevention Strategy and WCPH's Work

(U.S. Department of Health & Human Services)



Funding in 2023

Overdose Data 2 Action- WI Dept of Health Services (\$193,000)

- Allows WCPH to contract with Jennifer Skolaski, Ph.D., OFR Program Manager
- Increase understanding of community needs through listening sessions with parents in recovery and people that access harm reduction services.
- Community Naloxboxes
- Allows WCPH to fund childcare at Solutions Recovery, Inc

COSSUP (Comprehensive Opioid, Stimulant, and Substance Use Program)- Bureau of Justice Assistance (\$376,500)

- Allows WCPH to fund the Solutions Peer Response Team
- Expands capacity for the Fox Cities Victim Crisis Response Team to respond to events throughout Winnebago County
- Increases capacity of OFR Program Manager

Drug Free Communities- Center for Disease Control (\$125,000)

- WCPH is the fiscal agent of the Breakwater Coalition, focusing on youth substance use prevention.

Understanding Community Needs

- Connection & Belonging Report- led to funding childcare during recovery meetings and We Heart You Event
- Added Fentanyl and Xylazine Test Strips to WCPH services and provide Xylazine community and provider educational resources
- Held Parents in Recovery listening sessions to understand their unique needs. Report to be released by end of year and guide work into 2024.

d. Public Health (Ashlee Rahmlow)

- Public Health continues to provide fentanyl and xylazine test strips through the harm reduction program. Public Health collects data about behavior change after positive results of the test strips and we have collected the following information so far

- a. In the past 12 months, 230 clients had used FTS.
 - i. 164 (71%) clients reported a positive FTS
 - 1. 143 (87%) of clients made a change in their usage as a result of the positive
 - a. These changes include behaviors such as not using the substance, using with a friend, performing a wash, having Narcan available, using less/slower, etc.
 - b. In the past 4 months, 52 clients had used XTS. (XTS have only been distributed since June 2023).
 - i. 28 (54%) clients reported a positive XTS
 - 1. 25 (89%) of clients made a change in their usage as a result of the positive
 - a. These changes include behaviors such as not using the substance, using with a friend, performing a wash, having Narcan available, using less/slower, etc.
- Public Health continues to see wounds, presumably from Xylazine in the clinic. The Harm Reduction Program Coordinator is working with local providers and clients to support the treatment of wounds

e. Step Up (Chee Vang) – Talked about program, tries to help at risk youth and build mentorship. Created in 2011. Is trying to create structure for kids and work on mental health. Does a bootcamp style program with kids to get them to do physical activity. Doing more 1:1 mentorship, goes to TRUE Academy, shelter care and visit schools. 4 kids who are consistent with 1:1's.
