APPROVAL OF MINUTES:

Motion made by Key/Rengstorf to approve meeting minutes from June 18, 2010. Motion passed unanimously.

STATUS REPORTS:

Drug Court: Next graduation to be held on 09/24/10 with approximately 2-4 participants expected to graduate. On 09/22/10 will be meeting with Brown and Outagamie Counties to discuss Drug Court and how our program is set up and collaborate on ideas. They have been averaging in the 20's for program participants.

SSTOP: Current statistics distributed. Scott Woldt and Mike Olig have been traveling around the state explaining the program. Brown, Manitowoc, and Outagamie counties are exploring starting a SSTOP program.

Recidivism rate for participants is 9.9% over the last 4 years.

DAY REPORT: Currently there are 59 participants, all from the courts. Staff that are working on programs for jail inmates are compiling statistics regarding participation.

DOMESTIC VIOLENCE DIVERSION PROGRAM: New 20-week program beginning through Family Services. The DA's Office is meeting with Family Services on 09/13/10 regarding contracted staff that they are hiring to facilitate program. Discussed philosophy behind different research based methods for program.

CRIMINAL JUSTICE STUDY: Kimme & Associates has been selected to conduct the criminal justice study. They were provided contact information for this committee, the courts, law enforcement agencies, and probation and parole. They will be in contact with different groups in the near future regarding setting up meetings with individuals in the criminal justice system. The contract for services begins on 09/15/10. Discussed data collection.

JUVENILE TREATMENT COURT: Judge Karen Seifert will be the primary judge for the new juvenile treatment court, with Judge John Jorgensen assisting. The first hearing is scheduled for 09/16/10. Team meetings will be on Thursday from 2:30-3:30 and closed hearings will follow from 3:30-4:30. Staff recently returned from specialized training.

The juvenile treatment court team has applied for a \$5,000 grant through the Oshkosh Foundation's Crime Prevention Fund.
