- Scott Timm gave a current list of vendors that rent housing to 980 release offenders. He believes a few vendors were removed from the list that were no longer interested.
- The Corporation Counsel's office reached out to Attorney Alejandro Lockwood to get a list of other counties that placed offenders outside of their jurisdiction for a temporary stay. We have not heard back from him.
- One of the current residents of 851 County Road Y has been placed there for almost 3 years without any issues with law enforcement.
- The next court hearing is scheduled for June 20 at 9:00 am.
