 - 2018 Budget Preview: Mr. Moll handed out a preliminary budget report and explained various items.
- 4. <u>Hangar Condition Report</u>: Mr. Moll distributed a report of the airport hangars with notes on the condition of the hangars. A PowerPoint presentation with photos of various hangars accompanied the written report. More will be discussed at the next meeting to begin determining a plan for the buildings.
