APPROVAL OF JANUARY 14, 2016 MINUTES: Motion by Pauly, second by Mooney, to approve the January 14, 2016 Board minutes as printed. Motion carried.

CHAIR'S REMARKS: Chair Sundquist said a marketing plan is always somewhat elusive. As a group, the East Central ITBEC members have accomplished 90% on certain segments while being at ground zero on the rest.

PROJECT DIRECTOR'S REPORT: Bill Korrer informed the Board that with the county board supervisor elections and county board organizational meetings coming up in April, members' terms are set to expire. The ITBEC appointments run for 2 years.
