#### 1. Call to Order

Chairman Bill Wingren called the meeting to order at 9:00 a.m. and it was verified that the meeting was properly noticed.

#### 2. Consideration of Minutes of August 10, 2020 meeting

A motion to approve the minutes from August 10, 2020 was made by Paul Eisen, seconded by Tom Ellis. Carried 5-0.

#### 3. Public Comments on agenda items

Supervisor Brian Defferding asked about the voting process for those who are incarcerated and if they are still able to exercise their right to vote while being incarcerated. Sheriff Matz

responded by indicating there are flyers posted in each cell block laying out the process to the inmates on how to go about being able to vote. They have to put in a request for an absentee ballot and if they are out of county inmates, it is then communicated to the County Clerk of Winnebago County so she can then reach out to the county for which that inmate resides to obtain an absentee ballot.

# 5. Consideration (Vote): Budget Transfer - Accept \$75,614.00 "County Election Security Subgrant" from the Wisconsin Election's Commission - County Clerk Office - Sue Ertmer

Sue Ertmer discussed the federal government grant funding for election security. Winnebago County was awarded \$75,614.

A motion to approve the budget transfer of \$75,614 for the County Election Security Subgrant was made by Paul Eisen, seconded by Tom Ellis. Carried 5-0.

## 6. <u>Consideration (Vote): Budget transfer to allocate the subgrant funds to the appropriate accounts - County Clerk Office - Sue Ertmer</u>

Sue Ertmer discussed how she plans to allocate the subgrant funds for the election process and handed out an outline of where the money will go.

A motion to approve the transfer to allocate the subgrant funds was made by Mike Brunn, seconded by Vicki Schorse. Carried 5-0.

# 7. Consideration (Vote): Approve the 5-year maintenance contract for the hardware/software that supports our NG 911 upgrade. - Sheriff John Matz

Sheriff Matz discussed the maintenance contract and discussed that the hardware/software covers the Communication Center and First Responders equipment.

A motion to approve the 5-year maintenance contract for the NG 911 upgrade was made by Vicki Schorse, seconded by Mike Brunn. Carried 5-0.

# 8. <u>Consideration (Vote): Apply and Accept additional NG 911 grant of \$6,354.60 to cover the offset of new projected costs. - Sheriff John Matz</u>

Sheriff Matz discussed the original grant amount was \$219,000. The additional amount of \$6,354.60 is to cover offset of the projected costs.

A motion to approve the additional NG 911 grant amount of \$6,354.60 was made by Vicki Schorse, seconded by Tom Ellis. Carried 5-0.

## 14. <u>Consideration (Vote): 980 Sex Offender Status Update and Housing Considerations - Mary Anne Mueller, Mike Elder and Adam Dorn</u>

Mary Anne Mueller discussed she had received a request 3 months ago regarding the release of a 980 offender and she responded to the request. There will be an offender moving into the trailer within the next 3 to 4 weeks. October 9th is the anticipated release date of the offender. Mary Anne discussed there are several other offenders who are nearing release in the near future and they will need to start the process of finding housing for those individuals.

There was no vote taken on this item, only discussion.

# 15. <u>Discussion: Draft for a resolution to amend Sections 7.1, 7.2 and 8.8 of the Rules of the Winnebago County Board of Supervisors submitted by Supervisor Schorse - Corporation Counsel - Mary Anne Mueller</u>

Mary Anne and Vicki discussed the verbiage in the rule change and added an emergency line within the resolution.

Mary Anne discussed this was in regards to public comments. Vicki discussed a compromise in her version to allow an hour to an hour and a half to have agenda items addressed and any time left to allow for non-agenda items. Eisen discussed that it should be allowed that the public speak at the beginning but setting a time limit of 2 minutes per person for a hour to an hour and a half timeframe. Tom Ellis agreed with the 2 minute time

limit. It was discussed that they would speak with the County Board Chairman on the time limits during public comments and enforcing the time limits as well.
