1. Call to Order

2. Consideration of Minutes of October 14, 2019 meeting

A motion to approve the minutes from October 14, 2019 was made by Vicki Schorse, seconded by Tom Ellis. Carried 5-0.

4. Communications shared by Committee Members

Paul Eisen discussed his attendance at the November 3rd Esther Banquet.

It was at this time that Chairman Wingren asked to skip to item #6. The committee members agreed to move ahead with item #6.

6. Consideration (Vote): Budget transfer to add wages to Corporation Counsel Department for paralegal staff

Mary Anne Mueller is asking for a budget transfer of \$15,563.00 in additional funding to cover the paralegal overtime. She stated even with being fully staffed with paralegals, the amount of overtime

has not decreased within their workload. She has also worked with Human Resources to change the paralegals from a 37.5 hour work week to a 40 hour work week to help them complete more work within their work week.

A motion to approve the budget transfer to add \$15,563.00 to wages for the paralegal staff was made by Larry Smith, seconded by Vicki Schorse. Carried 5-0.

5. Discussion – Problem Solving Approach to Criminal Justice – Christian Gossett, District Attorney

Christian Gossett and Carol Morack from the Department of Human Services discussed the Problem Solving program and what the grant will be used for that the District Attorney's Office is going to be using. Currently the Department of Human Services is administering shots to opioid users. The shot decreases the cravings drugs users have to help them get clean from using drugs. They are also proposing a Justice Service Center for the program which will come at a later time to accommodate for the program.

The committee asked for a layout of the program and shown how the grant money will be used.

7. Sheriff's Report

- Sheriff Matz stated the Sheriff's Office will have a float in the Oshkosh Holiday Parade
- Sheriff Matz stated the Sheriff's Office has been busy with accidents due to the early winter weather
- Sheriff Matz stated the Sheriff's Office has responded to two fatal accidents in the last week
- Sheriff Matz stated Neenah Police Department arrested the homicide suspect from the Neenah incident. The Sheriff's Office assisted in taking that individual into custody.
- Sheriff Matz indicated the jail count is at 295
