Reviewed alternative options: 1) Winnebago County would elect not to provide an additional ramp. 2) Winnebago County pursues adding lake access off the Wiouwash Trail. 3) Winnebago County assists Town of Oshkosh to investigate feasibility of constructing boat launch on east side of Lake Butte des Morts. 4) Winnebago County could assist Town of Oshkosh in looking for alternative boat launch sites. Committee is leaning toward option 2. Parks Department will start working on MOU with Town of Oshkosh.
