1. Call to Order

6. Discussion: COVID-19 and COVID-19 Vaccine Updates

a. <u>COVID-19 Outbreak Status/Update</u> – There has been continued weekly testing for all staff and residents, along with a second testing weekly for unvaccinated staff. Park View is in outbreak status at this time and closed for admissions. However, the building remains open to visitors.

- <u>COVID-19 Vaccinations Update</u> Staff continue to be encouraged to take the vaccine on a regular basis. The facility conducted another vaccination clinic in the month of December for booster doses.
- c. <u>Mandatory COVID-19 Vaccinations Amongst Nursing Facilities Discussion</u> The mandate has resumed and the facility is working with Winnebago County Human Resource Department to implement new regulation.
