- PVHC will be participating in the DHS Caregiver Career Program beginning in 2018.
- Human Resources will be bringing a resolution to the Personnel & Finance Committee in November regarding setting shift differentials for PVHC CNAs and LPNs.
- Nurse Call System Update The vendor has completed the background installation. There
 will be a meeting tomorrow to finalize the transition to the new system.
