Updates:

We have a commencement scheduled for June 30th for 2 more graduates. We will likely hold one near the end of the year for 3 more graduates. Continue to be operating in person for Drug Court and commencement ceremonies, with a Zoom option available for those who are unable to attend in person due to illness, treatment or travel restrictions, or for those observing that are not in the area. We also continue to allow participants who are out of the area in treatment facilities, appear in court weekly via Zoom.

We have been speaking at the local high schools to the freshman health classes. We went to both Oshkosh West and Oshkosh North HS last year. We also have 2 summer school sessions we are speaking to as well.

The Drug Court team attended the annual WATCP (Wisconsin Area Treatment Court Professionals) conference in Wisconsin Dells from 5/4-5/6/22 and gained valuable knowledge into trends of treatment courts in the state and nation.

We have also been consistently holding quarterly team meetings as well to ensure we are operating within the best practices standards and update or revise our materials as needed.

Eric Sparr – recently receiving larger number of applicants. Normal application submitted per month are 1-2 per month. Currently receiving 7-8 applications, but most do not qualify.

c. Breakwater -formerly WCDAC (Stephanie/Hannah for Ashley)

Update:

- Winnebago County Overdose Fatality Review Team is creating the 2021-2022 Annual Report, which will be released in August
- OFR partners submitted a \$1.3 million COSSAP grant proposal to support overdose prevention and grief bereavement support after overdose death
- The DHS Spike Alert pilot program that Winnebago County is part of has demonstrated an increase in overdoses between April and May
 - April = 34 overdoses reported in the ED and 18 overdoses reported by EMS
 - May = 39 overdoses reported in the ED and 35 overdoses reported by EMS (highest number of overdoses per month in the past 9 months)
- Fentanyl test strips and Narcan can be obtained by individuals at Winnebago County Health Department (provided at no cost through grant support)
- Intern is working with Breakwater through August
- Working with Communities at North High School on the Be Courageous campaign and created an anonymous Be Courageous podcast, which can be found under "The Breakwater Podcast" on most platforms.
