## **NEW BUSINESS**

Status update regarding Rayfe J. Paulick and placement options.

On June 21<sup>st</sup> the Winnebago County Board approved over \$1,000,000 to design and construct a residential facility for 980 violent sex offenders. On July 8, 2022 Mike Elder (Facilities Director), Todd Christie (Sheriff's Department) and Mary-Anne Mueller (Corporation Counsel) met with the City of Oshkosh to discuss the process needed to proceed with the residential facility. The City of Oshkosh requires a final site and landscaping plan for the proposed facility for review.

A week later Mike Elder (Facilities Director), and Mary-Anne Mueller (Corporation Counsel) met with an Architect and discussed the site plan to be submitted to the city. They anticipate the plan will be created in the first part of August. There have a status conference with Judge Jorgensen on August 17. The deadline to find housing is August 25.

An Assistant Corporation Council reached out to state vendors provided by Angela Serwa. We received responses from the state vendors but none of them meet our requirements. The Assistant Corporation

Council is continuing to reach out to other vendors. At this point we are continuing to move forward with the residential facility.

Adam Dorn indicated he updated the County's GIS with current locations of parks, daycares, schools, nursing homes. This will be used to assess the suitability of potential site locations.
