### Meeting Minutes

New balance after today's approval for the VSC portion of funds is \$17,703.55. There are no FVVC charges until next month since billed quarterly. The FVVC meeting are very open and they are looking for us to push applications their way.

**Old Business:** Jeff has had several more meetings with County Executive Jon Doemel and they have also toured the Neenah building together. He is very supportive of Neenah office move. Bob and Tom have also had 1 on 1 meetings with Mr. Doemel.

The Veterans Service Organizations are again having their events this summer. Seems really good! Jeff will also start making his rounds again visiting all VSO Post in Winnebago County which were halted due to COVID. The Office traffic is starting to pick-up which is a good sign. 2022 Budget is starting and no cuts have been requested. Seems pretty standard again this year.

**New Business:** Tom again spoke on the CVSO Act which has not yet been reintroduced. Congressman Gallagher will co-sign this time. Parameters of Act again reviewed.

The CVSO Grant coming from WDVA is going up about \$1,400.00. The Appleton Veterans Village now has funding to remodel all remaining apartments. Now looking towards fund raising efforts for assisted living.
