## **Old Business:**

Jeff gave the following office updates:

- We have hired two new Benefit Specialists to fill our two vacancies. Shane, who is an Army veteran, will be starting July 28 and Theresa, who is a county transfer from DHS in Neenah and the spouse of an Army veteran (her start date to be determined).
- Six-month update for our office. As of today's date we currently have 692 pending claims actions with a 112 of those in a "decisions ready" state. Retroactive VA payments to date for the year are \$2.5 million, so we are off to a very good start for the year.
- The VA released its GDX report and veteran populations in Winnebago County are down over 300 from last year due to a higher than normal mortality rate. Total VA spending in Winnebago County is at \$85 million for the year, which is up from the previous year.

- Mental Health Summit will be held in Fond du Lac at the fairgrounds. This a Multi-County effort/program. The Federal and State VA will also be participating
- We will have a booth at the County fair and at the EAA.

## **New Business:**

• Tom updated the commission with the PACT Act. It was passed with changes in the Senate and must now go back and be approved by the House of Representatives.
