Website Design & Development

Phase 1: Design

24 hours = \$3,000

In this phase, wisnet's creative team will design the website's layout, look, and feel. Designs will follow any previously established brand standards and brand desires.

- Homepage design concept
- Estimated design concepts of 3 interior pages, plus theme elements
- Up to 2 rounds of revisions.
 - Additional revisions will be estimated at our hourly billable rate of \$125/hour.

Phase 2: Development

64 hours = \$8,000

In this phase, wisnet's developers will program and build the approved design from Phase 1, including CMS installation and customization, CSS & SCSS, scripting, jquery, javascript, ajax calls, database connections, user permissions & accessibility, and more. An early outline & estimate includes:

- With top priorities focusing on functionality within:
 - Scalability & Ease of Growth
 - SEO Foundation
 - Custom Content Blocks
- A user-friendly page builder to allow Endless Shores to quickly and easily add/edit/remove content post launch
- Training on the editor for Endless Shores to get familiar with the toolset

Phase 3: Content Migration

16 hours = \$2,000

In this phase, wisnet's team will build out pages and migrate content over from the current site.

Estimated Total Cost: \$13,000



Phase 4: Post-Launch Refinement and Support

As a means of coming to terms with the realities of development, let's say it out loud together on three. One... Two... Three!

Because of this, wisnet charges for bug fixes. Bugs happen all over the place with every sized team. From large corporate entities with 1,000's of developers and testers on payroll, down to our humble but mighty team of a baker's dozen. With that out of the way, during Phase I we'll work with your team to outline what support will look like for post launch requests and issues that get raised by your initial user base. As well as how you'd like to tackle those items along the way. Typically these workflows are leveraged for either larger scale websites or web applications, but for your reference here are some examples of what we've structured for other projects:

Weekly Budget Threshold

• We'd set a threshold of X hours per week to work on a prioritized queue set by you, the client, for our team to then tackle in order, leveraging the hours available each week.

Issue Threshold

• Issues would be submitted by you, the client, for our team to review. If estimated billable time is under X hours, then they are performed and submitted for review. If estimated billable time is at or above X hours, then a quote is shared for you, the client, to approve or reject the adjustment. If approved, development ensues. If rejected, it is put into the backlog until deemed valuable to pursue development.

Issue by Issue

• Our team would be funneled issues by you, the client, only when you want us to scope out the adjustment and then tackle it after given explicit approval to incur the project cost and timeline.
