Background:

Winnebago County has been administering shoreland zoning since 1968 pursuant to requirements in state law. The Town of Winchester has submitted commentary on County Shoreland Zoning authority to the County Executive's office and Planning and Zoning Committee. The issue is currently under review by the County Executive's office.

Policy Discussion:

All ordinances in the County are the responsibility of the County Executive to carry out pursuant to ss 59.17(2), Wis. Stats., including Shoreland Zoning. Under state law, all counties in the state are mandated to carry out and enforce state shoreland zoning in designated shoreland areas of their unincorporated areas. These mandates are codified in sections 281.31, 59.692, 59.69, Wis. Stats. and Natural Resources Code NR-115. Pursuant to this, the County Executive's office will provide the Planning and Zoning Committee with an update on the issue of Shoreland Zoning authority and will have an attorney working for the Wisconsin Counties Association present at the meeting to respond to the issue and answer any questions of the Committee.
