Chairman Albrecht turned the chair over to Vice Chairman Brennand. Vice Chairman Brennand stated that

because this amendment could potentially impact his family, he would not be participating in discussion or action on it.

Motion by Supervisor Albrecht and seconded to adopt. Supervisor Albrecht corrected the amount in the

Amendment from \$410,000 to \$400,000.

Supervisor Roh expressed his concern that because this Amendment does not specify which page or account number(s) in the budget the \$400,000 should be added to, it is in violation of the Wisconsin open meetings law and should not be addressed at this time. Corporation Counsel Bodnar explained that these budget meetings have been properly noticed for the public and that amendments to the budget can be made during these meetings. Mr. Bodnar stated that the Board is not in violation of the open meetings law if they act on Amendment 7.

Motion by Supervisor Eisen to postpone action on this Amendment indefinitely. No second to this motion. Vice Chairman Brennand turned the chair back to Chairman Albrecht.

Vote on Amendment – Ayes: 16. Nays: 15. Abstain: 1 – Brennand. Excused: 2 – Widener and Neubauer. CARRIED.

Various Supervisors challenged whether this Amendment passed because they felt that an abstention should be counted as a "no" vote, in which case the amendment would lose. After consulting the Board's rules, Corporation Counsel Bodnar stated that he believes this motion lost. However, after the close of this meeting he will look into it further and if he discovers that his opinion is not correct, he will notify the County Clerk, the County Board Chairman and County Executive. Chairman Albrecht stated that he accepts Mr. Bodnar's decision that this Amendment failed and will not pursue the matter any further.

Chairman Albrecht called for a brief recess so that Supervisor Hegg's amendment could be distributed to the Board.

The Board reconvened at 12:30 p.m.

In reference to Amendment No. 7, Corporation Counsel Bodnar reversed his earlier decision that the amendment lost. Citing a 1984 Wisconsin Court of Appeals decision, he explained that because Supervisor Brennand believed he had a legal obligation to abstain from voting on Amendment 7 and did abstain he is not considered present when, "calculating a majority number required for passage of legislation". Based on this, Amendment 7 passed with 16 aye votes and 15 nay votes. Chairman Albrecht ruled that Amendment No. 7 passed.

# AMENDMENT (8): Recognize the Sustainability Project with the UW-Extension Budget and Track Using a Separate Project Number with the UW-Extension Department

BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby recognizes the Sustainability Project in the UW-Extension Department in the amount of \$1,500.
