

**SPECIAL ORDERS SESSION  
COUNTY BOARD MEETING  
TUESDAY, MAY 3, 2011**

Chairman David Albrecht called the meeting to order at 6:00 p.m. in the County Board Room, Fourth Floor, Courthouse, 415 Jackson Street, Oshkosh, Wisconsin.

**PUBLIC HEARING**

No one addressed the Board.

**REPORTS FROM COMMITTEES, COMMISSIONS & BOARDS**

Supervisor Nancy Barker updated the Board on the activities of The Glacier Land Resource, Conservation & Development Board. They have had recent funding cuts.

Supervisor Tom Widener brought the board up to date on the Scholarship Program. This year 25 essays were received from 10 different schools and 16 Supervisory Districts. This year essays were received from Ripon and Berlin, which is a first for the scholarship program.

Supervisor Lennon told the board that the Aviation Committee will be meeting on Thursday, May 12, which is a change from the normal meeting time. She stated that the meeting will go until all questions are answered regarding the proposed land acquisitions.

Supervisor Wingren commended Supervisor Widener on the Scholarship Program directions on the County website.

**COUNTY BOARD CHAIRMAN'S REPORT**

The State of Wisconsin has not met regarding state highway projects. They have finally met and the Tri-County freeway project is a go ahead. The tentative schedule is: June/2011 – interviews, Summer/Fall of 2011 – Consult Design Team Selected and Design Kickoff. Summer/2012 50 % of design completed. Summer/Fall of 2013 Plans completed for earliest let out projects. Summer/2014 earliest anticipated construction started. Spring/Summer of 2016- latest anticipated construction start, 2017 – earliest construction anticipated finish. 2019 – Latest construction finish. Chairman Albrecht also informed the board that a letter had been received from the Glatz Trust, asking to be pulled out of consideration for the purchase of their property for the airport.

**PUBLIC HEARING ON TENTATIVE REDISTRICTING PLAN**

Jason Weber gave a brief talk on prescription drug abuse. The big problem facing not only Winnebago County, but the whole nation is prescription drug abuse. Prescription drugs are the deadliest drug in the State of Wisconsin. Officer Weber gave an outline of how this program came about and how the program has grown throughout the State of Wisconsin. The program is available in a tool kit with a CD and DVD. There is a good possibility that this program will go nationwide.

After the Power Point Presentation, the group took questions from the board.

2. Wisconsin County Mutual Insurance Corporation/Aegis Corporation – John Dirske  
Mr. Dirske told the board that to date, Wisconsin County Mutual Insurance posted a very good year in terms of loss ratio, and in terms of effective services that members had requested. Challenges continue and we need to prepare for different challenges each and every year. There is constant changing environment in regulation and litigation. Mr. Dirske talked about the Governor's budget and what is being done if it passes. He then took questions from the board.
3. CIP Terminal/FBO Ramp Reconstruction Project – Peter Moll – Wittman Regional Airport  
Peter Moll told the board that this project is in the airport 2011 budget. This is a terminal and fixed based operator entry reconstruction. He directed the board's attention to a hand out that was placed on the supervisors' desks. It gives the background of this project. There will be 95% FAA funding with 2.5% coming from the state and the county's share would also be 2.5% or \$105,000.00 The project will be completed over 3 years – with the county paying \$35,000.00 each year. Mr. Moll took questions from the board regarding this project.
4. Discussion on Tentative Redistricting Plans  
Two maps had been placed on the supervisors' desks, Option 2 and Option 3. The new census will have each supervisor representing approximately 4639 citizens. This is an increase of about 200+ people over the last census. Jerry Bougie and Diane Culver from the Planning Department went over how the maps were created. The pros and cons of both options were discussed by the board.
5. Siren Warning Process – Linda Kollmann – Emergency Management Director  
Linda Kollmann gave a Power Point presentation on what happens during the siren warning process.

Sirens are tested Saturday at noon April – early October. A report of what sirens didn't work is generated on Monday and the Facilities Department Electricians are notified which sirens need fixing. There are 4 siren zones in Winnebago County, Zone A covers the Southeast part of the County, Zone B is for the Northeast part and Zone C is the Northwest Section and Zone D covers the Southwest part of the County.

## WINNEBAGO COUNTY SIREN ACTIVATION GUIDELINE

The National Weather Service places Winnebago County under a Tornado Warning

A Winnebago County weather spotter observes an actual funnel cloud, and the sighting is confirmed.

When there are straight-line winds, or downburst in excess of 90 mph.

Ms. Kollmann told the board that NOAA Weather radios are the “smoke alarms” for danger.

Emergency Radios pick up emergency information 24 hours

It is critical to have on all the time, especially at night

The message will come directly from the National Weather Service and other agencies immediately

Alerts you to weather dangers like tornados and floods and chemical emergencies

NOAA radios saves lives

### HOW TO BE ALERTED.....

Always check out weather before leaving home

TV (morning news, weather channel, etc.)

Radio – on the way to destination

Internet – check local TV stations or Weather Channel

Cell phone alerts

NOAA Weather Radio

Tornado Siren ( Outdoor event alerting)

Monitor weather throughout your day

DO NOT RELY ON ONE FORM

Be informed, stayed informed! You are responsible for your own safety!
