#### **AGENDA ITEM #1: ELECTION OF OFFICERS**

Bill Topel opened nominations for Chairperson. Tom Widener nominated Jim Koziczkowski for Chairperson; seconded by Ron Kuehl. Jerry Finch moved that nominations be closed and a unanimous ballot cast for Jim Koziczkowski for Chairperson; seconded by Larry Lautenschlager and carried (9-0).

Jim Koziczkowski opened nominations for Vice-Chairperson. Ron Kuehl nominated Tom Widener as Vice-Chairperson; Mike Norton nominated Larry Lautenschlager. Nominations for Vice-Chair were closed. Paper ballots were cast with the following outcome: Larry Lautenschlager -5 votes; Tom Widener -3 votes; anonymous vote -1.

Jim Koziczkowski opened nominations for Secretary. Harold Singstock nominated Mike Norton as Secretary; seconded by Jerry Finch. Jerry Finch moved that nominations be closed and a unanimous ballot cast for Mike Norton for Secretary; seconded by Ron Kuehl and carried (9-0).

## <u>AGENDA ITEM #5: INDIVIDUALIZED YOUTH SERVICES (IYS) – JONATHAN STONE</u>

Jonathan Stone is the director of the Individualized Youth Services Program through CESA-VI, which provides one-on-one services to severely emotionally disturbed youth. Leo Podoski said we make referrals to IYS, and they match the service to the individual needs of the child. We started contracting with CESA-VI in 2003 for \$330,000. They are currently serving 33 youth in the program, but we have a need for about 40 youth being served. We are looking for Jonathan to hire more staff and provide more service hours, as there is a waiting list for services. Jonathan explained that youth with severe emotional disturbance sometimes find themselves in situations in the community, school or home where they can become extremely violent due to their symptomatic behaviors. The IYS staff mentors the youth for several hours after school. They help them work on their daily living skills, and they include opportunity for recreational activities. Jonathan said the community has been very supportive of this program. They are available to provide services seven days a week, giving parents an additional resource to de-escalate a situation. Many of their 50 staff members are college students that work part-time. The counties of Fond du Lac, Outagamie and Winnebago are the primary referral sources to IYS.

### AGENDA ITEM #6: INPATIENT & INSTITUTIONAL PLACEMENT STATISTICS

Bill Topel referred to the chart of placement statistics through March. The Juvenile Corrections average daily population (ADP) remained at 3.0; Residential Care Centers' average has declined slightly from 12.6 to 11.6; the ADP for Specialty Hospitals, adult population admissions is slightly down to 4.9 from February's 5.5 ADP; the ADP for Specialty Hospitals for individuals under age 22 has changed from 1.6 in February to 2.7 in March; the Secure Detention ADP is at 5.7 or a decrease from 6.4; and Foster Care's ADP is 107.5 or a decrease from 110 in February. Bill said Foster Care is our least costly service.

## AGENDA ITEM #8: DISCUSS POSSIBLE LETTER TO DHS RE: MONTHLY RENT PAYMENT FOR SEX OFFENDERS

Jerry Finch asked the Board to support Senator Mike Ellis in his concern regarding the amount of rent that is paid by the state for sex offenders, which could be up to \$2,200 per month. Jerry suggested we send a letter to the Department of Health Services to express our support of the recommendations listed in the report from the Legislative Audit Bureau to reduce the cost of supervised release placements, such as establishing written policy to guide the process in identifying potential residences. Tom Widener moved that we approve the request to send a letter to DHS; seconded by Mike Norton and carried unanimously. Bill Topel will draft and send the letter on behalf of the Board.
