Review and Approve Winnebago County Water Quality Improvement Program Cost Share Agreements (CSA) to provide funding for eligible projects

Following a brief review of Herb Treu's waterway and wetland restoration project, a Bohn/Barker motion to approve \$4,900.00 in cost sharing for Mr. Treu passed 5-0.

## Review Deer Donation Program History for Winnebago County
