<u>Approve August 1, 2013 LCC Meeting Minutes:</u> A Barker/Neubauer motion to approve the August 1, 2013 LCC meeting minutes passed 6-0.

- Tom D. announced that the Emerald Ash Borer (EAB) had been located and confirmed in the Town of Black Wolf in Winnebago County. Tom D. informed the LCC that UWEX and WDNR Staff would be providing public education on the issue.
