DRUG COURT:

JUVENILE TREATMENT COURT:

SSTOP:

Current statistics distributed. Document handed out for committee to review regarding thoughts on how the program may be expanded.

DAY REPORT:

There are currently 53 - 57 participants utilizing Day Report. All are from the courts.

24/7 PROGRAM:

Brief explanation of the program and the two types of testing available (PBT and SCRAM). Beginning 09/01/11 all PBT testing is being handled by the Neenah Police Department and

Winnebago County Sheriff's Office. Currently there are 82 participants on the program, 60 on SCRAM and 22 on PBT testing. Comment to keep the Courts appraised if number of participants on program begins to exceed program's capacity.

DOMESTIC VIOLENCE DIVERSION PROGRAM:

Current statistics distributed. Participant numbers have been restructured for 2012 (anticipate approximately 100 participants annually).
