- 1. Call to Order: P. O'Brien called the meeting to order at 9:01 a.m.
- 2. <u>Approve Agenda:</u> Motion to approve the July 20, 2011 agenda with the elimination of agenda Item 9, made by K. Robl and seconded by P. Brennand. Motion carried 8-0.
- 3. Public Comments on Agenda Items: None.
- 4. <u>Announcements/Communications:</u> P. Eisen presented the SWMB with a single stream recycling and hazardous waste advertisement that was in the newspaper, brochures from Outagamie County Recycling and a Request for Proposal advertisement for the Law Enforcement Center (LEC) absorption chiller.

Discussion ensued amongst the SWMB.

5. <u>Approval of Minutes – July 6, 2011 Open Session:</u> Motion to approve the July 6, 2011 open session minutes, made by J. Finch and seconded by P. Brennand. Motion carried 8-0.

- 6. <u>Discussion 2011 Final Cover Sequence C-3 Construction Project Update (SW03-11):</u> J. Rabe updated the Solid Waste Management Board (SWMB) on the Final Cover Sequence C-3 Construction project as follows:
 - Mueller Excavating (Mueller) making good progress with clay cap placement but recent weather delays impacting schedule (14 weather days thus far).
 - American Environmental Group (AEG) started geomembrane deployment on July 14, 2011, but has been shut down since July 18, 2011.
 - Geocomposite materials began to arrive on July 20, 2011 and AEG will hopefully begin installation later today.
 - Terra Engineering & Construction will begin vertical gas well installations on July 25, 2011.
 - Scheduled final completion date of September 9, 2011 is still the target.

Discussion ensued amongst the SWMB.

7. <u>Discussion/Action – Retained Earnings Reservation</u>: J. Rabe informed the SWMB of two (2) recommended changes to Retained Earnings Reservation as follows:

- J. Rabe summarized the proposed modifications to allocation amounts as follows:
 - Change fund description from "Rate Stabilization Recycling" to "Debt Service– Recycling"
 - o Increase fund reservation by \$1 million to \$1.4 million. This will be used to offset the \$300,000/year debt service costs of the new facility that can't be passed along to municipalities (current balance of \$2.385 million as of April 5, 2011).
 - Increases to "Surplus for Future Solid Waste Transportation" by \$1.3 million to \$5.6 million. This will be used to offset future transportation costs and soften tipping fee increases.
 - Net result is a \$21.2 million allocation amount and \$1.16 million deficit.

M. Easker suggested that the SWMB should have 10% of their budget in reserves (undesignated for operational cash flow).

Discussion ensued amongst the SWMB.

Motion to add an undesignated reserve fund to the Retained Earnings Reservation that is 10% of the current year's operating budget, made by M. Easker and seconded by D. Albrecht. Motion carried 8-0.

General consensus of the SWMB is to have staff revise the Retained Earnings Reservation document to show the 10% undesignated reserve fund and discuss at a future meeting.

8. <u>Discussion/Action – Landfill Gas Project Updates:</u> J. Morris provided the SWMB with the Sunnyview Landfill 3rd blower/oil water separator/flare modification project schedule as follows:

- J. Morris reminded the SWMB that the proposals for the Snell Road Landfill Gas Blower and Flare System installation project came in over budget. The electrical/controls design was modified and a new RFP was issued on July 5, 2011. The proposal due date was recently extended 1 week to July 26, 2011.

Discussion ensued amongst the SWMB.
