He believes that balancing resources to demand is an administrative issue. Question raised as to what is driving a higher demand? Some is the economy, new OIE/OEF returnees and also attitude of staff.

New Business: July CVSO Report distributed. Robert commented on increase in pending files. There are several reasons for this but 1 is the lack of extra help this summer. He has utilized some funds from the CVSO grant for 2 extra hours/day for the office secretary. Another reason is the increase in veterans that are disagreeing with VA decision. Stan commented that all numbers on CVSO report were higher than last year so it would make sense that the pending files are up also. Robert spoke on 2 specific widow death pension cases that brought in retroactive benefits to the claimants that more than cover the total budget for the CVSO office for a year. The return to the county is \$109 per \$1 spent!

The annual meeting for the Veteran Service Commissioners is slated for September 7th in Waupaca. Judy will call commissioners with final details when agenda comes out. Dale Witzke stated that he planned on attending.
