REPORTS FROM COMMITTEES, COMMISSIONS AND BOARDS

Supervisor Barker reported on her attendance at a Glacierland Resources Development meeting where they discussed how to dispose of trees that are infected with the Emerald Ash Borer. She stated that they are recommending that counties start making plans now so that they are prepared to dispose of this wood.

Supervisor Finch asked for clarification of the wording that was used to amend Resolution No. 296-102009 at the October 20, 2009 meeting, specifically the term "at arms length". John Bodnar, Corporation Counsel, explained that "at arms length" means the parties are free to negotiate an agreement, but there is not an obligation to come to an agreement.

Supervisor Eisen reported that he attended the Wisconsin Library Association Conference in Appleton, where he attended a meeting with representatives from the Department of Public Instruction (DPI) in Madison. The DPI representatives stated that in these economic times, a "new increase" in budgets is a "zero increase".

AMENDMENT (1): INCREASE AIRPORT'S CAPITAL-LAND ACCOUNT BY \$1.2 MILLION FOR PURCHASE OF LAND ON THE EAST SIDE OF AIRPORT

BE IT RESOLVED by the Winnebago County Board of Supervisors that it hereby amends the 2010 Winnebago County General Budget so as to add \$1.2 Million to Airport-Land Account #5800, on Page 263 of the Winnebago County Budget.

BE IT RESOLVED by the Winnebago County Board of Supervisors that funds to pay for said additional expense are to come from fund balance in Airport Fund.

AMENDMENT (7): REDUCE FRINGE BENEFITS

WHEREAS, the Fringe Benefits for Winnebago County employees represent a rapidly increasing percentage of total employee compensation, particularly health insurance costs.

WHEREAS, the Winnebago County Board of Supervisors also recognizes the impact that escalating health care costs have on existing employees.

THEREFORE, BE IT RESOLVED that the Winnebago County Board of Supervisors strongly recommends that the County Executive and Human Resources negotiate that effective January 1, 2010 the cap on the employee contribution for health insurance costs would be eliminated for all new employees.

BE IT FURTHER RESOLVED that the 2010 budget amount for Health-employer share on Page 20 be reduced by \$45,000 to reflect this recommendation and that this be applied to County Department budgets proportionately.

WHEREAS, the Fringe Benefits for Winnebago County employees represent a rapidly increasing percentage of total employee compensation.

WHEREAS, currently Winnebago County pays both the employer and employee shares of the Wisconsin Retirement System contributions.

WHEREAS, Winnebago County Board of Supervisors recognizes the effect that payment of the employee share would have on existing employees.

THEREFORE, BE IT RESOLVED that the Winnebago County Board of Supervisors that effective January 1, 2010 each new employee hire would be responsible for 50% of the employee share contribution to the Wisconsin Retirement System.

BE IT FURTHER RESOLVED that the 2010 budget amount for Wisconsin Retirement-employee share be reduced by \$66,000 to reflect this recommendation and that this reduction be applied to County Department Budgets proportionately.
