I, Investigator Jim Goggins, received a letter from District Attorney Christian Gossett who had been given this letter by Circuit Court Judge Barbara H. Key. This letter stated there was a Petition for Waiver of Fees and Costs and Affidavit of Indigency that had been filed with the Court by Peter J. Long. This was in regard to Case No. 13GF001. The Court believed that the affiant, Peter Long, had falsely swore that he was receiving food stamps when he signed the affidavit on December 17, 2012. Additionally, on the same case, the same affiant, the defendant swore he was represented by the State Public Defender's office which, according to Judge Key, the defendant was not.

The Court further contacted the Wisconsin Department of Corrections and was interned by them that on the date of filing of the Petition for Waiver of Fees and Costs, that the Petitioner,

Peter Long, was an inmate of the Wisconsin Prison System and therefore not receiving food stamps. Further, the Petition indicates that there was only \$200.00 in his checking account and that he further owns property in Winnebago County, therefore the Court found the Petitioner not to be indigent.

After receiving this information I checked the Wisconsin Circuit Court Access Program (CCAP), and found that in Winnebago County, from May 16th, 2012 through December 18, 2012, the defendant, Peter Long, filed ten (10) cases with the Courts in Winnebago County where he swore that he was receiving food stamps and/or representation by the Public Defenders Office and that he was indigent. He also swore and signed an affidavit in each of those cases.

- Case No. 2013GF001, filed before Judge Key the defendant signed as the affiant, indicated that he was receiving both food stamps and representation by the Public Defenders Office. Denied by Judge
- Case No. 2012GF026, filed before Judge Woldt, the defendant signed as the
 affiant, indicated that he was represented by the Public Defenders Office. In this
 case he did not claim food stamps. It was denied by Judge Woldt.
- Case Nos. 2012GF0018, 2012GF0014, 2012GF0013, 2012GF0012, filed before Court Commissioner Kuech, the defendant signed and swore to by the defendant where he claimed he was receiving food stamps and legal representation from the Public Defenders Office which was in not true. Court Commissioner Kuech denied each case.
- Case Nos. 2012CV1642 and 2012IP10, filed before Judge Jorgensen, the
 defendant signed as the affiant, both claimed he was represented by the Public
 Defenders office but did not claim he was receiving food stamps. Both cases
 were granted by Judge Jorgensen.
- Case No. 2012IP0007, the case was filed twice, both times before Judge Gritton.
 The first filing was on May 16th, 2012 and the second filing was on July 24, 2012.
 In these cases, the defendant claimed he was receiving food stamps and was being represented by the Public Defenders Office. First time denied, 2nd time granted.

**Of the ten (10) cases filed by Peter Long, the defendant, nine of the cases were notarized by a notary name Robert P. Zabkowicz. Robert Zabkowicz is the librarian and a notary for Fox Lake Correctional Institute in Dodge County where Peter Long the defendant was incarcerated at the time of these filings. I sent a copy of each signature to Mr. Zabkowicz and he confirmed that he was the notary on each of those cases and he personally knows Peter Long and the signature was Peter Longs. He indicated that the signature is in fact Peter Long's and Peter Long signed it in Robert Zabkowicz' presence.

The other case, 12GF0013, was notarized and was also done at Fox Lake Correctional Institute while Peter Long was incarcerated. The notary on this case was

Julie L. Bassuener who also confirmed, after receiving a copy I sent to her, that Peter Long did sign in her presence and swore to her that it was a correct statement. Since the time of that signing Julie's last name has changed to Dahm. Both Julie Dahm and Robert Zabkowicz can be reached at Fox Lake Correctional Institute, 920-928-6957.

Count 1: FELONY FALSE SWEARING, REPEATER

The above-named defendant on or about Tuesday, July 24, 2012, in the City of Oshkosh, Winnebago County, Wisconsin, did make or subscribe a false statement which he did not believe to be true, when the oath or affirmation was authorized or required by law, contrary to sec. 946.32(1)(a), 939.50(3)(h), 939.62(1)(b) Wis. Stats., a Class H Felony, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than six (6) years, or both.

And further, invoking the provisions of sec. 939.62(1)(b) Wis. Stats., because the defendant is a repeater, having been convicted of Simulating Legal Process in Chippewa County 08 CF 68 on May 20, 2008, which conviction(s) remain of record and unreversed, the maximum term of imprisonment for the underlying crime may be increased by not more than 2 years if the prior convictions were for misdemeanors and by not more than 4 years if the prior conviction was for a felony.

Count 2: FELONY FALSE SWEARING, REPEATER

The above-named defendant on or about Wednesday, October 31, 2012, in the City of Oshkosh, Winnebago County, Wisconsin, did make or subscribe a false statement which he did not believe to be true, when the oath or affirmation was authorized or required by law, contrary to sec. 946.32(1)(a), 939.50(3)(h), 939.62(1)(b) Wis. Stats., a Class H Felony, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than six (6) years, or both.

And further, invoking the provisions of sec. 939.62(1)(b) Wis. Stats., because the defendant is a repeater, having been convicted of Simulating Legal Process in Chippewa County 08 CF 68 on May 20, 2008, which conviction(s) remain of record and unreversed, the maximum term of imprisonment for the underlying crime may be increased by not more than 2 years if the prior convictions were for misdemeanors and by not more than 4 years if the prior conviction was for a felony.

AFFIDAVIT IN SUPPORT OF CRIMINAL COMPLAINT

Goggins/ Curtis/ Venne, of the Winnebago County District Attorney's Office, being first duly sworn on oath and in that capacity has knowledge of the following:

Your affiant is informed from the reports of the Winnebago County District Attorney's Office kept in the normal and ordinary course of business in which your affiant believes to be truthful and reliable and have proven so on numerous occasions in the past that In early 2013, Inv. J. Goggins of the Winnebago County District Attorney's Office investigated PETER J. LONG, D.O.B. 9/19/67, fraudulently claiming that he was receiving food stamps and being represented by the State Public Defender in order to obtain fee waivers on cases filed in Winnebago County Circuit Courts. Inv. Goggins found ten Petitions for Waiver of Fees and Costs from May 16, 2012, to December 18, 2012, where Long claimed that he was currently represented by the State Public Defender and/or was receiving Food stamps/FoodShare.

On January 23, 2013, Inv. Goggins spoke with a representative of the State Public Defender in Winnebago County, Wisconsin. Inv. Goggins was informed that Long had not been represented by the Public Defender since 2008. Inv. Goggins contacted Fox Lake Correctional Institute, W10237 Lake Emily Road, Fox Lake, Dodge County, Wisconsin. Long was incarcerated at Fox Lake Correctional Institute from January 30, 2012, to January 15, 2013. On March 18, 2013, Inv. Goggins spoke to Ann Kriegel, supervisor for Income Maintenance at Winnebago County Human Services. Kriegel reported that Long was not receiving food stamps from May, 2012, to December, 2012.

One of the incidents of false swearing was in connection with the Petition for Waiver of Fees and Costs - Affidavit of Indigency and Order filed by Long in Winnebago County 12 CV 1642. Long checked the box indicating that he was currently receiving legal representation based on indigency, and noted that it was from "Wisconsin State Public Defenders Program." The document appears to be signed by Long on October 31, 2012, and was sworn to Robert Zabkowicz. The fee waiver was granted by Hon. John Jorgensen on November 12, 2012, after

being submitted to the Circuit Court in Winnebago County, Wisconsin. It does appear that the affidavit must be sworn to apply for waiver of fees.

Another incident of false swearing was in connection with the Petition for Waiver of Fees and Costs - Affidavit of Indigency and Order from Winnebago County 12 CV 1171 (12 IP 07). Long checked the box indicating he was represented by the "State Public Defenders Program" based on indigency. Long appears to have signed the affidavit on July 24, 2012, and it was sworn to Robert Zabkowicz. The fee waiver was granted by Hon. Thomas Gritton August 6, 2012, after being submitted to the Circuit Court in Winnebago County, Wisconsin. A similar Petition had been filed and denied in the same case where Long also included that he was receiving Food stamps/FoodShare. That Petition was denied by Hon. Thomas Gritton on July 13, 2012, indicating "show proof beyond section 1." Long had sworn the affidavit to Robert Zabkowicz on May 15, 2012.

Inv. Goggins spoke to Zabkowicz, who stated he was the librarian and a notary for Fox Lake Correctional. Inv. Goggins sent Zabkowicz the documents at issue, and Zabkowicz confirmed that he was the notary in each incident, and that he was familiar with Peter Long, and that Long had signed each document in Zabkowicz's presence.

CCAP records, which have proven to be reliable in the past, show that Long was convicted of felony Simulating Legal Process in Chippewa County 08 CF 68, with a date of conviction of May 20, 2008.

All of the above incidents occurred in Winnebago County, Wisconsin.

DEFENDANT'S MOTION TO DISMISS

HERE COMES the Plaintiff, Peter J. Long, appearing pro se, hereby moves the Court to dismiss all the charges (Counts 1 & 2), and dismiss this entire case. The grounds for this Motion are as follows:

COMPLAINT ALLEGES THAT THE DEFENDANT, PETER J. LONG, WAS NOT REPRESENTED BY THE STATE PUBLIC DEFENDER'S OFFICE DURING 2012:

- Defendant Long was arrested for OWI (5+) on September 15, 2011 in Washington County. Washington County Case No.: 2011-CF-0345. This case is still in the Washington Circuit Court – Branch 1, and ongoing.
- The Washington County State Public Defender's Office ("SPD") appointed
 Attorney William A. Mayer to represent Defendant Long on September 16, 2011.
 (See Exhibit "A" Notice of Appointment)

- 4. Therefore, Attorney Mayer, appointed by the SPD Office, represented Defendant Long during the entire 2012 year.
- Attorney Mayer is still currently representing Defendant Long on the Washington County Case No.: 2011-CF-0345.

COMPLAINT ALLEGES THAT THE DEFENDANT, PETER J. LONG, WAS NOT RECEIVING FOOD STAMPS DURING JULY 2012:

- 6. Defendant Long's Food Stamp Case Number is: 4140497742.
- Defendant Long received Food Stamps financial assistance prior to his Extended
 Supervision Revocation Sentence during 2011.
- 8. Defendant Long had a positive balance on his Food Stamp account in the amount of \$639.45, at the time of his arrest in Washington County for Case No.: 2011-CF-0345.
- 9. Defendant Long maintained these Food Stamps benefits, positive balance of \$639.45 during his entire incarceration which included all of the 2012 year.
- 10. Therefore, during July 2012, Defendant Long still maintained Food Stamps benefits in the amount of \$639.45, but was unable to use them due to his incarceration. However, these Food Stamps benefits still existed during July 2012.
- 11. Exhibit "C" is Defendant Long's official Food Stamp EBT Transaction Detail for the year 2013 to date. Defendant Long was released from prison, Fox Lake
