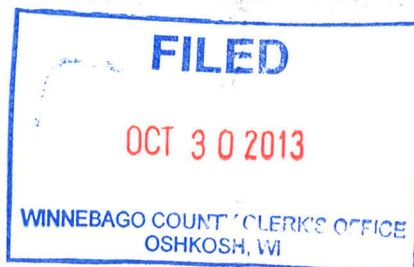
X-RAYS and LAB TESTS:

If you had a culture done it will take 24 to 72 hours to get the results. If there is a change in the x-ray diagnosis or a positive culture, we will contact you. Please verify your current phone number prior to discharge at the check out desk.

MEDICATIONS:

If you received a prescription for medication(s) today, it is important that when you fill this you let the pharmacist know all the other medications that you are on and any allergies you might have. It is also important that you notify your follow-up physician of all your medications including the prescriptions you may receive today.

On October 21st, 2013 I had a meeting
with my Counselor George Benn. I
went into the bathroom to freshen up
before our visit. I slipped and fell
in the Bathroom of the Dept. of Human
Services (1st floor ladies room) 220
Washington, Osh, WI 54901. I sprained
my right foot and my lower back. I
met with Ron Montgomery and he took
a accident & injury statement. The Dept
did cover my cab ride to Mercy Medical
to be treated. Ron Montgomery was very
harsh and rude to me over the phone once
I stated I did want to file a claim.
I'm requesting monies for the Hospital
fees, all medication, and my pain and
suffering. I DO NOT have any health
insurance but was refered to the Living
healthy clinic and was treated again.
They sent me to Theda Care for X-rays

and I'm still waiting on the results.

I have photos of the sink and ~~and~~ all the water dripping down. I have no insurance and I'm having problems and can't afford constant trips to the E.R. My hip to my right foot is still in great pain. I also took pictures of the accident sight on my phone. Margie Johnson went into the bathroom and did witness the sink running over with the garbage bag taped over the sink. It was at that time she put up a out of order sign on the bathroom door and a Caution Wet sign outside the door.
