

I, Peter J. Long, am the owner of PJL Properties, LLC which owns and operates the Wilson Avenue Apartment Complex locate at 310-320 W. Wilson Avenue in the Town of Menasha in Winnebago County. On 9-14-11, at approximately 11:40 p.m., I attempted to collect past due rent from the tenants who lived in Apt. 320-\*5 named William Cook and Mitchell Kemper. These tenants owed \$794 in past due rent for August and September 2011 and had promised to make a \$300 payment that evening after 10:30 p.m. They knew I was coming over to collect rent that night. After

knocking on the door and identifying myself verbally as the Landlord, they refused to answer the door and were laughing at me. I knocked louder and talked louder demanding my past due rent money. These tenants had been legally served a "5-Day Notice To Pay Rent-Or Vacate" on 9-6-11. I was being nice by not filing the exiction on the 11th of September 2011 and then these tenants disrespected my kindness. They never answered the door so I left and went back to my apartment. All my actions as Landlord were legal and I made no verbal threats. An EVICTION was filed (Winnebago County Case No.: 2011-SC-3448) and granted by Court Commissioner Kuech on 10-12-11.

Then I left my apartment with a friend in his vehicle to get some late night food because we were going to go to Milwaukee to visit two girlfriends of mine. Apparently, William Cook and Mitchell Kemper called 911 and made up lies about me to get me into trouble because they knew I was on "parole" (ES-Extended Supervision) for OWI. If I was arrested, they thought I would be unable to collect rent or evict them. They lied to Officer Colburn-TMPD.

At 12:35 a.m. on 9-15-11, I received a cell phone call from Dispatcher Jennifer Davis of the Winnebago County Sheriff's Department (W.C.S.D.) because my cell phone vibrated. I turn my ringer off after 10 p.m. at night. WCSD J. Davis told me to answer my door because a TMPD Officer was pounding on it and needed to talk to me about a disturbance at Apt. 320-#5. I told her that would not be possible because I was not at home and was headed to Milwaükee for a date with two girlfriends of mine. I informed her that I would be back home in a couple days and would be happy to discuss the matter then with the TMPD Officer. I was in good spirits, on my way to have some fun with two girlfriends of mine, and made NO threats to hurt or kill anybody. At no time did I threaten to kill the tenants, william Cook and Mitchell Kemper, and I did NOT tell the WCSD Dispatcher, Jennifer Davis, that I was going to Milwaukee "to kill someone". WCSD Dispatcher calls are all recorded. My attorney and I have both filed "Open

Records Requests" for a CD recording of ALL WCSD Dispatcher communications related to TMPD Incident Reports: TP11-2834 & TP11-2835. No response as of date on this Notice of Claim.

On 9-15-2011, at approximately 1:30 a.m., the WESD Dispatcher, Jennifer Davis, entered a FALSE teletype about me that contained the lie, "but obtained info via phone that Peter was enroute from the Town of Menasha to the Milwaukee area 'to kill someone'. "Nobody heard me threaten to hurt or kill anybody because I never spoke those words or made any threats. I have no history of violence and any allegations against me should have been denied or verified using the Wisconsin Department of Corrections "after hours" Monitoring Center in Madison, WCSD Jennifer Davis knew I was in good spirits and headed to Milwaukee on a date when she entered the FALSE teletype.

I have a Constitutional Right to be free from police harassment, misconduct, and privacy intrusions. This FALSE teletyper led to a meritless, harassing, and illegal privacy intrusive traffic stop on HWY 41 in Washington County when I was on my way to Milwaukee for my date. This FALSE, vindictive, illegal ATL teletype is the "cause of action" to my current incarceration and

WCSD Dispatchers/Operators take an OATH to tell the truth and have a ministerial duty to tell the truth and NOT enter an ATL teletype that contains, knowingly, FALSE statements

and this duty is NOT discretionary.

I preserve my right to pursue a civil action based on this cause of action and/or the offense of FALSE SWEARING pursuant to Wis. Stats. § 946.32 and/or the offense of OBSTRUCT-ING OFFICER pursuant to Wis, Stats, § 946.41 and/or the offense of DEFAMATION pursuant to Wis. Stats. § 942.01 and/or SLANDER/LIBEL.
