Thanks for the telephone call today regarding the zoning change permit issued by the Town of Vinland for the above parcel.

When Chuck Farrey and I first did the listing of parcels to be rezoned from A-1 to either A-2 or R-1, this parcel was identified for R-1 because it was less than 5 acres. That is when the "Proposed Town Zoning Map" was created by for us by Diane Culver. When we sent the notice to the land owner of our intent, he reminded us that the Town promised him his land would remain A-2. Years ago when the cul de sac was created on Dobberke Lane, the Town took some of this parcel reducing it to 4.969 acres. As a result of all this, I issued the correct Zoning Change Permit, but did not realize the map did not match.

It is the wish of the property owner and the vote of the Vinland Town Board that parcel #026-0310 be zoned A-2, and the split zoning be eliminated.


