- 1. Town of Vinland has recommended approval of including parcel No. 026-0162-01 in the County's Farmland Preservation Plan.
- 2. The Town of Utica submitted a resolution recommending the inclusion of various parcels in the County's Future Land Use Plan. The resolution did not make reference to the single property owner requesting the removal of their property from the Farmland Preservation Plan.
