1. Approval of minutes from October 15 (Viewing), October 20 (Public hearing), October 29 (Deliberative), October 29 (Planning Meeting) and November 12, 2021 (Viewing).

Committee reviewed minutes as presented. Motion by R. Keller, seconded by B. Defferding, to approve October 15 (Viewing), October 20 (Public Hearing), October 29 (Deliberative), October 29 (Planning Meeting) and November 12, 2021 (Viewing) minutes as presented. Motion carried 5-0.

Committee action on 2022 schedule of meetings.

Committee reviewed proposed 2022 schedule of meetings. Motion by R. Keller, seconded by M. Gabert, to approve proposed 2022 schedule of meetings as presented. Motion carried 5-0.

3. Report on Non-Metallic Mining Reclamation Program & Committee action on 2022 proposed fees and budget.

Scott Konkle from ECWPRC presented a report summarizing the status of extraction sites and the proposed budget and fees for 2022. One new site was added and two sites are near completion for reclamation. The proposed fee for 2022 is \$35.00 per acre. Mr. Konkle requested a motion by the committee to approve the

proposed \$35 per acre fee. Motion by B. Defferding, seconded by M. Gabert, to approve the proposed fee of \$35.00 per acre for 2022. Motion carried 5-0.

4. Committee review and action to forward town zoning ordinance amendment to County Board.

Committee reviewed memo from Zoning Administrator regarding the town zoning change for Darrell Budde (Tax ID: 028-0398-04 & 028-0398-04 – Town of Clayton). Motion by B. Joas, seconded by B. Defferding, to move to County Board for approval. Motion carried 5-0.

5. <u>Discussion on AB608 and AB610 in the state legislature.</u>

Jerry Bougie summarized the proposed bills and what, if any effect, they would have on the responsibilities of the Zoning Department. Mr. Bougie added that one bill could have a minimal impact on the responsibilities of the Zoning Department with regard to providing addresses on newly created plats and but it is understood that both bills had no support. Ethan Hollenberger stated that he had spoken with members of a few organizations and came to the same conclusion with regard to the lack of support for the bills. B. Defferding stated that he wanted to place these bills on the agenda for discussion because he had concerns with the state imposing additional regulations on local municipalities.

Motion by M. Gabert, seconded by B. Defferding, to adjourn the meeting. Motion carried 5-0. Meeting adjourned at 8:26 am.
