As a self-developer, we have only a single care-setting, and our behavioral health clinic does not utilize the Electronic Health Information Export [(170.315(b)(10)]. Therefore, we have developed a process for testing this module that does include real production data but does not necessarily reflect actual customer usage of the module.

Our approach represents our best effort to simulate a real-world situation in which a care provider would want to extract information to be transitioned to another EHR.
