AVAILABLE NOTIFICATIONS

- **Tax bill has been created.** Subscribers will receive a notification 24 hours after tax bills are calculated and published for web viewing.
- **Tax bill payment is being processed.** This notification will be generated after a receipt for payment has been received for processing by the County Treasurer.
- **Tax bill installment payment is due.** Subscribers will receive a notification that an installment payment is due if the full amount has not been paid in the 1st or subsequent installments.
- **Tax bill is marked as delinquent.** A notification is sent that a tax bill is delinquent 24 hours after the County Treasurer marks the bill as delinquent.

HOW TO SIGN UP/CREATE AN ACCOUNT

- Click on the subscription link (may not be exactly as shown):

- If you choose email, you will be returned to the Subscribe/Log In screen. Once you are returned to this screen, check your email - you will be receiving a confirmation from the County. This email (shown below) contains the link which you will need to continue.
