## Walk-In Wednesday Vaccine Clinics at Sunnyview Expo Center will Continue Through July

**OSHKOSH, WIS. (July 13, 2021)** – The Winnebago County Health Department will continue offering free walk-in COVID-19 vaccination clinics at Sunnyview Expo Center (500 E County Road Y, Oshkosh, Wis.) from 1 p.m. to 6 p.m. each Wednesday for the remainder of July.

"Our health department staff have already administered over 25,000 doses of the COVID-19 vaccine at the Sunnyview Expo Center in Oshkosh," said Doug Gieryn, director/health officer for the Winnebago County Health Department. "Our Walk-In Wednesday clinics have become a consistent, reliable vaccine resource in our community. As a reminder, to be fully vaccinated by the time public school starts you need to get your first dose this week or next."

All three COVID-19 vaccines are available at Walk-In Wednesday clinics, giving people a choice between the Johnson & Johnson/Janssen, Moderna or Pfizer vaccine. Vaccination is open to all individuals aged 12 years and older. Appointments are not required, and there has been little to no wait time. Nurses are also available to answer any questions people may have.

"We continue to have demand for our Walk-In Wednesday clinics, so we are happy to open our doors again to provide the community with a safe and convenient location to get the COVID-19 vaccine," said Kim Goffard, public health supervisor-communicable disease, Winnebago County Health Department. "One thing our public health nurses do really well at our clinics is answering any questions people may have so they can make a decision they are comfortable with."

## About the Vaccines:

- Johnson & Johnson/Janssen is a one-dose vaccination.
- Moderna and Pfizer are both a two-dose vaccination series.
- Participants will be considered fully vaccinated 14 days following the completion of their vaccination series.
- Pfizer is currently the only vaccine approved for individuals aged 12 years and older.
- Anyone under the age of 18 should plan to have a parent/guardian present.
